## **Emergency Overview**

Physical Description & Colour: yellow coloured liquid.

**Odour:** Pleasant Lemon Fragrance.

Major Health Hazards: no significant risk factors have been found for this product.

#### **Potential Health Effects**

#### Inhalation

Short Term Exposure: Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

## **Section 6 - Accidental Release Measures**

#### Accidental release:

**SMALL SPILL:** do not normally need any special cleanup measures. Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal
